REVIEW OF REIKI PRACTITIONER TRAINING



WHAT WE CAN OFFER

The UK Reiki Federation is able to provide a review of a practitioner's existing training against the 2009 National Occupational Standards for Reiki and the recommendations of the Reiki Council.

The UK Reiki Federation will arrange for a qualified Assessor to evaluate the training and experience of the practitioner and either provide confirmation that the training meets recommendations, or will provide the practitioner with a Review & Action Plan of additional items to be covered.

The individual is then responsible for completing any recommended actions.

WHAT THE PRACTITIONER SHOULD BE AWARE OF

All those submitting details for review should base their information on the current National Occupational Standards for Reiki and the Core Curriculum of the Reiki Council.

WHAT INFORMATION IS REQUIRED?

You will receive a Review of Reiki Practitioner Information Pack which will give you information to help you put together a portfolio of information to support and demonstrate your competence against the standards. The pack will give you guidelines as to the type of evidence you could use for this.

You will be allocated an Assessor, who will be the person to carry out the formal review and assessment of your portfolio. The Assessor will contact you by email and is there to help you put your folder together.

When your portfolio/folder is complete it is then sent to the Assessor who will provide one of two things:

- a) If all standards are met – practitioner will receive a certificate of verification from the UK Reiki Federation
- b) If there are gaps in the evidence or training – the practitioner will receive a Review & Action Plan prepared by the Assessor which can then be used to supplement the existing training. It will be the responsibility of the Practitioner to carry out the recommended activities.

COST?

The cost for a review of the portfolio is £140.00.

Should the practitioner wish further reviews/assessments to be carried out, these will be charged at £25 per hour.

HOW TO GET YOUR CURRENT TRAINING REVIEWED AND VERIFIED?

Send completed application form to the UK Reiki Federation with your cheque for £140.00 made payable to the UK Reiki Federation.

You will receive your formal Review of Reiki Practitioner Information Pack and will be allocated an Assessor who will help you through the process.
