## **WHAT WE CAN OFFER**

The UK Reiki Federation is able to provide a review of proposed CPD courses for Reiki Practitioners.

The UK Reiki Federation will arrange for a qualified Assessor to evaluate the proposed CPD course and to either provide confirmation that the course can be accepted into the Directory of Approved Courses, or to provide the teacher with feedback when it cannot be included. On acceptance a Certificate of Verification will be issued by the UK Reiki Federation, and the Course will be eligible for entry in the UK Reiki Federation's Directory of Approved Courses. Courses for CPD, and will be approved for a period of three years

## **WHAT THE TEACHER/CENTRE SHOULD BE AWARE OF**

All those submitting course details for review and verification should aim to provide information to indicate that the course would be suitable as CPD for a Reiki Practitioner. The submission should include a syllabus or list of topics to be covered, methods of training/teaching, documentation to be provided to candidates and any certification to be issued.

Both in person and distance learning courses may be considered.

## **WHAT INFORMATION IS REQUIRED?**

The Teacher/Centre will need to complete the Course Review and Verification forms included in this pack, and provide a copy of the full syllabus for the proposed course, and evidence that they are qualified or experienced to run the course.

## **COST**

The cost for this service is £120 per course to be reviewed.

3. Provide CV or qualification certificates
4. Provide sample manual/handouts
