

# GUIDELINES FOR APPLICANTS FOR MEMBERSHIP

## Notes and checklist:

1. If you tick the data protection boxes in the top section you cannot then be included on the practitioner listings. We do not sell our mailing list to third parties.
2. Student (S) membership applications should include the Confirmation From Reiki Teacher form filled in by a teacher that they are currently undertaking Reiki training. Student (S) membership is valid for one year and members may convert to Associate (A) membership once they have gained their Reiki 1 certificate.
3. Section: Practitioner Membership Categories Only – please clearly print all details. Only complete this section if you want your website to be on the practitioner listings and have paid the extra £10.00 in your order. Shown in this section is for those who have their own website and wish it to be included on the listings – the website must be active on application.

## Please note that to be a practitioner member you must send us:

- a) At least one Reiki certificate which is more than 9 months old
- b) A certificate at level 2 or above. Exact level of membership within the practitioner categories is determined by the highest level of certificate received, or a lower category if selected by the applicant.
- c) A copy of your current practitioner insurance covering you for Reiki or if you do not have this, confirm that you have sent an application for insurance through our Block Scheme to Balens.
- d) A copy of your lineage (i.e. like a family tree), which traces your style of Reiki back to Usui, this can be obtained from your Reiki teacher. This is a requirement for national registration.

Those applying for Master Teacher (MT) membership should have held their Reiki 1 for 12 months, and ensure that their teacher certificate clearly indicates that they can teach, attune or initiate if the full title “Master Teacher” is not shown. If in doubt please contact us before sending in your application.

4. Section: Details of Reiki training – please clearly list all levels of Reiki training and certificates you are enclosing. Distant attunements are not acceptable for membership purposes.
5. Section: Main style of Reiki – this is the style you use most frequently
6. All applications should be supported by a character reference from a person of professional standing in the community, who is not a relative/partner and who has known the applicant for at least 3 years. People of professional standing include JPs, lawyers, accountants, health care professionals, religious officials or senior figures in business, the public sector or voluntary sector, teachers, the individual’s Reiki Teacher.
7. Have you enclosed?
  - Payment – cheques payable to UK Reiki Federation
  - Photocopies of all necessary Reiki Certificates/documents as detailed above
  - Evidence of your insurance as detailed above (practitioner category)
  - Copy of your lineage back to Usui
  - Completed Character Reference Form
  - Completed Confirmation From Reiki Teacher Form (for Student (S) membership only)
8. Have you signed the form? By signing the form you are stating that you have read and agree to abide by our Code of Ethics.
9. Please calculate the correct postage for your application. Underpaid postage causes delays. Please take note that large C4 (A4 size envelopes) or envelopes weighing more than 100g, are classed as “Large Letter” and incur a higher charge for postage. We will only collect underpaid items on a weekly basis.
10. Please note that we ask for 28 working days for processing, and normally we process applications well within that period. Constant calls and emails to check on progress before this period has elapsed may cause delays.

Practitioner membership is an acknowledgement that individuals have received a minimum level of training, hold practitioner insurance and have signed a Code of Ethics.
